- 12. The 1080P PTZ camera shall conform to the ONVIF standard to provide interoperability with other conformant systems.
- 13. The 1080P PTZ camera shall offer three separate and configurable streams with individually configurable streams.
- 14. The 1080P PTZ camera shall have an autofocus lens with 30x optical zoom.
- 15. The 1080P PTZ camera shall have variable pan and tilt speeds, and autopivot capability for optimal camera control and viewing at all zoom levels.
- 16. The 1080P PTZ camera shall offer bi-directional audio.

# A. General Characteristics:

- 1. The 1080P PTZ camera shall provide a 1/1.9-in. type CMOS progressive-scan camera with the following:
  - a. 1920 x 1080 effective picture elements.
  - b. Sensitivity to below 0.002 lux.
- The 1080P PTZ camera shall offer an IR distance of up to 500 m (1640 ft).
- The 1080P PTZ camera shall provide direct network connection using H.264. and MJPEG compression and bandwidth throttling to efficiently manage bandwidth and storage requirements while delivering outstanding image quality.
- The 1080P PTZ camera shall support the following dual, redundant power options:
  - a. 24 VAC.
  - b. High PoE.
- 5. The 1080P PTZ camera shall provide a rules-based auto-tracking feature to automatically track moving object.
- The 1080P PTZ camera shall utilize and algorithm that dynamically adjusts the cameras contrast settings to provide usable image quality in scenes affected by fog, smog, mist, smoke or other low contrast scene.

# C. PTZ Features

- 1. The 1080P PTZ camera shall provide a pan range of 360° continuous.
- 2. The 1080P PTZ camera shall provide a tilt angle of -20° to 90° relative to the horizon.
- 3. The 1080P PTZ camera shall provide an automatic flip feature to automatically rotate and flip the camera as it tilts through the vertical position to maintain the correct orientation of the image.
- 4. The 1080P PTZ camera shall provide the following modes for variable pan/tilt speeds:
  - a. Manual Control:
    - 1) Pan: 0.1°/s to 200°/s
    - 2) Tilt: 0.1°/s to 120°/s
  - b. Preset Mode:

- The 1080P PTZ camera shall provide a feature that automatically rotates, or pivots, the camera to simplify tracking of a person walking directly under the camera.
- 6. The 1080P PTZ camera shall divide the cameras 360° rotation into 16 independent sectors with 20-character titles per sector. Any or all of the 16 sectors can be blanked from the operator's view.
- 7. The 1080P PTZ camera shall support 300 presets.

# E. Streaming Capability

# F. IP Connectivity

- 1. The 1080P PTZ camera shall allow full camera control and configuration capabilities via a TCP/IP network.
- 2. The 1080P PTZ camera shall deliver 1080P video, at rates up to 25/30 frames per second via TCP/IP over an RJ-45 (10/100 Base-T) connection.
- 3. The 1080P PTZ camera shall conform to the ONVIF, PSIA, and the CGI standard.

- 4. The 1080P PTZ camera shall offer Quality of Service (QoS) configuration options.
- 5. The 1080P PTZ camera shall support the IPv6 internet-layer protocol for packet switched internetworking across multiple IP networks.
- 6. The 1080P PTZ camera shall offer local and network storage options that include: MicroSD, Network Attached Storage (NAS), and recording to a local PC for instant recording.
- 7. The 1080P PTZ camera shall support the following protocols: IPv4/ IPv6, HTTP, HTTPS, SSL, TCP/IP, UDP, UPnP, ICMP, IGMP, SNMP, RTSP, RTP, SMTP, NTP, DHCP, DNS, PPPOE, DDNS, FTP, IP Filter, QoS, Bonjour, and 802.1x.
- 8. The 1080P PTZ camera shall support the Android and the IOS mobile operating systems.

#### G. Audio Capabilities

- 1. The 1080P PTZ camera shall support the following audio compression technologies: G.711a, G.711Mu,G.726, AAC.
- 2. The 1080P PTZ Camera shall offer an audio interface with one (1) channel IN and one (1) channel OUT.

# H. Intelligence

- 1. The 1080P PTZ camera shall offer a built-in Intelligent Video System to provide advanced analytics for any scene.
- 2. The Intelligent Video System shall offer intelligent video analytics built-in to the 1080P PTZ camera.
- 3. The Intelligent Video System shall be capable of processing and analyzing video within the camera itself, with no extra hardware required.
- 4. The Intelligent Video System shall trigger an alarm and take a defined action for the following events:
  - a. Standard Features
    - 1) Tampering with the camera.
    - 2) Error writing to an onboard Micro SD Card.
    - 3) Error sending or receiving data over the network.
    - 4) Unauthorized access to the camera.

#### b. Premium Features

- 1) Motion: object moves through any part of the scene.
- 2) Tripwire: a target crosses a user-defined line.
- 3) Intrusion: a target enters or exits a defined perimeter.
- 4) Scene Change: a person or object moves the camera to change the scene or covers the camera to obscure the scene.
- 5) Abandoned/Missing Object: a target leaves an object in a designated area, or a target removes and object from the same designated area.
- c. Advanced Features
  - 1) Facial Detection: detects and captures a snapshot of a human face in a defined area within a scene.
  - 2) Heat Map: generates a visual representation of data.
  - 3) Auto-tracking: controls the pan/tilt/zoom actions of the camera to automatically track an object in motion and to keep it in the scene.

- I. Installation Requirements
  - 1. The 1080P PTZ camera shall be capable of operating in an outdoor environment within a temperature range of -40° C to +70° C (-40° F to 158° F).
  - 2. The 1080P PTZ camera shall accept power, transmit video, and accept control via a TCP/IP connection.
  - 3. The 1080P PTZ camera shall support the following dual, redundant power options:
    - a. 24 VAC ± 25%.
    - b. High PoE.
